

Globus Maritime Limited reports delivery of the vessel "Island Globe"

Athens, Greece - September 2, 2009. Globus Maritime Limited ("Globus" or the "Company") (AIM: GLBS), an owner and operator of Handymax and Panamax dry bulk vessels, announces that on September 1, 2009 it delivered the M/V "Island Globe", a Panamax bulk carrier of approximately 73,119 DWT built in 1995 in S. Korea, to its new owners, an unaffiliated third party.

About Globus Maritime Limited

Globus is a global provider of seaborne transportation services for dry bulk cargoes, including among others iron ore, coal, grain, cement, and fertilizers, along worldwide shipping routes. On September 2, 2009, Globus owns and operates one Panamax and five Handymax vessels, with a weighted average age of approximately 11.7 years (as at August 31, 2009) and a total carrying capacity of 299,250 DWT.

Following the delivery of the "Gulf Globe" to her new owners, the Company will own and operate one Panamax and four Handymax vessels with a weighted average age of approximately 11 years (as at August 31, 2009) and a total carrying capacity of 256,005 dwt. All the vessels are geared.

Globus is listed on the AIM of the London Stock Exchange under ticker GLBS. Jefferies International Limited is acting as nominated adviser and broker to the Company.
