#### About Globus Maritime Limited

Globus is a global provider of seaborne transportation services for dry bulk cargoes, including among others iron ore, coal, grain, cement, and fertilizers, along worldwide shipping routes. It owns and operates five sister-ship geared Handymax vessels, and one Panamax vessel. Globus has also entered into an agreement to acquire a newbuilding handymax vessel scheduled for delivery in December 2007. When this acquisition is completed, Globus' fleet expands to a total of seven dry bulk carriers, consisting of six Handymax vessels and one Panamax, with a weighted average age of approximately 10.9 years as at 31<sup>st</sup> December, 2007 and with a total carrying capacity of 342,629 dwt.

All six vessels in Globus' current fleet are on medium to long term time charters to reputable charterers, which is expected to provide a stable revenue and earnings base.

Globus is listed on the AIM of the London Stock Exchange under ticker GLBS. Jefferies International Limited is acting as nominated adviser and broker to the Company.
